In continuation to this Ministry's letter of even number dated 21.09.2017 and in reference to your representation dated 23.09.2017, I am directed to say that after careful reconsideration of the matter in terms of provisions of HCC(MSR) Regulations, 2013, report of hearing committee and policy of the Central Government for granting conditional permission during the session 2017-18, permission of the Central Government is hereby granted to Bakson Homoeopathic Medical College, B-36, Knowledge Park, Phase-I, Greater NOIDA, Dist. Gautam Budha Nagar, for continuing admissions in existing PG course in 07 subjects with 06 seats each for the academic session 2017-17 subject to condition that the college shall fulfill the following requirements by 31st December, 2017 which will be verified for granting permission from the academic session 2018-19:

all the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013" by 31st December 2017 to get permission for a period not exceeding five years. Failing which, all the existing colleges, which are not able to achieve full compliance of the requirement as specified in these regulations by the 31st December, 2017, shall be denied permission from academic year 2018-19 onwards and action as envisaged under section 19 of the Act shall be initiated against all such colleges apart from rejection of their applications under sections 12A, which have been under consideration by way of conditional permissions or denials"; and

- ii. all the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder should be fulfilled *in toto*.
- iii. availability of cadavers and mummifies bodies in dept. of anatomy, model and specimen in dept. of Medicine.
- 4. The fulfillment of the conditions attached to the permission given above may be made within the specified time period and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCH also. The CCH will verify by means of an inspection that the conditions have been fulfilled and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the session 2018-19.
- 5. The College has to comply with the full requirements of HCC (MSR) Regulations, 2013 by December, 2017 for continuing admissions during the subsequent years. CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2018-19 and furnish the recommendations to the Central Government.
